The bids will be opened in the presence of Bidder's representatives who choose to attend at 1:00PM on 2080/07/23 (9-Nov-2023) at the office Of Agnisair Krishnasabran Rural Municipality, Sitapur, Saptari. Bids must be valid for the period of 90 days after bid opening and must be accompanied by a bid security or scan copy of the bid security in pdf format in case of e-bid, amounting to a minimum of NRs 53000 which shall be valid for 30 days beyond the validity period of the bid.
- 7. If the last date of purchasing and /or submission falls on government holiday, then the next working day shall ne considered as the last date. In such case validity period of the bid security shall remain the same as specified for the original last date of bid submission.
